

Request for information (“RFI”) on infrastructure investment opportunity in Japan

Government Pension Investment Fund ("GPIF") actively invests in infrastructure in Japan and overseas markets, and for the purpose of promoting our activities in Japan, we will gather information on potential investment opportunities in the domestic infrastructure market (including proposals for co-investment program or opportunity) from relevant companies in the market.

Description of RFI

In this RFI, we will gather information related to investment opportunities including, but not limited to the following items;

- Overview of the opportunity
- Sector:
e.g. renewable energy, telecommunication (data centers, fibers, towers, etc.), electric power (transmission and distribution, power generation facilities, battery storages, etc.), transportation (railways, airports, ports, parking, etc.), gas pipelines, water and sewerage, district heating, energy transition-related businesses including hydrogen and ammonia businesses, waste management, PPP/PFI-related businesses, etc.
- Investment Scope : All domestic infrastructure investment opportunities (not limiting stage of development or method)
- Expected investment amount
- Investment structure
- Timing of investment execution
- Business overview of the information providing company
